Violin Shop of Old Carmel staff will attempt to charge the amount owed for a month plus a \$10.00 late fee to the Credit Card on file if a payment is late by one week (7 days). If a scheduled payment is past due by 30 days, items on this Layaway contract will be placed back on the Showroom Floor and this contract will be considered null & void. Violin Shop of Old Carmel rejects all responsibility to notify customers of payment due-dates, charges on late payments, and contract nullifications. All payments made towards Layaway items are considered final and non-refundable. All items on Layaway will remain in Violin Shop of Old Carmel's possession until the final payment per contract has been received. Once Layaway items have been paid for *in full*, the Layaway item(s) are held to the same Return Policy Guidelines as all other merchandise. ## **Violin Shop of Old Carmel's Return Policy**

-  All accessories are to be returned with an appropriate receipt for store credit or cash/credit card refund. If customer does not have receipt, store credit will be issued.
-  There will be no refunds or credit issued after 30 days from date of purchase.
-  All purchased instruments and bows must be returned with an appropriate receipt for store credit only.
-  Rental instruments that are returned before the end of the rental contract period will receive a refund for the remaining time on contract. You will only receive a refund for whole months remaining on the agreement. Note: Any damages made or discounts given will be deducted from your refund amount.
-  Any item over \$50.00 will receive store credit only.
-  Returned Checks: Any "bounced" check or payment returned from our bank for insufficient funds or any other reason will be re-charged to the customer who made the delinquent payment for the full purchase amount paid previously plus a \$28.00 fee incurred to us by our bank for each returned payment made.
-  We deduct a 5% Processing Return Fee on all Returns for Returned Items originally purchased with a credit card.
