Responsibilities:

- Lender will furnish instrument and bow in good playing condition with a case.
- Borrower is responsible for any damage to, loss, or theft of above equipment for total value. Repairs, if any, are to be performed only by The Violin Shop of Old Carmel. If repairs are found to be done by anyone outside of The Violin Shop of Old Carmel, Borrower must take a full responsibility of purchasing the instrument. INSURANCE, If chosen & paid for, covers any damages, repairs, maintenance to the Instrument, Bow and Case ONLY, NOT Strings. Loss, theft or Acts of nature, as fire, flood etc. are NOT covered.
- Borrower will purchase any broken strings and have them professionally replaced by an employee of The Violin Shop of Old Carmel. Insurance does not cover string costs.
- The undersigned Borrower further acknowledges he or she has provided the Lender with his or her valid credit card information below and expressly acknowledges, agrees, and authorizes Lender to charge credit card for the total rental fees, total value of any damage, or the total value of the musical instrument in the event of loss of the instrument or failure to return or purchase the instrument at the end of the rental period. The total value for the instrument, bow and case is \$ _____. Borrower further agrees to immediately notify Lender of any change in his/her credit card information furnished below, and of any change to his/her personal information, as an Address, Phone Number with the Voice Mail set up, and email during the rental period of this rental contract.
- Lender may give a courtesy reminder call for all rental fees; however, Borrower is **fully** responsible for paying rental fees on or before the expiration of the rental period. Lender is not responsible for sending invoices or bills. If Borrower does not pay rental fees by the rental expiration date, he/she will be charged late fee \$10.00 per week at the next renewal.
- If Borrower does not pay rental fees, return, or purchase the instrument within one week of the rental expiration date, Lender will automatically re-new the rental contract and charge the credit card listed on The Contract for rental fees, tax, insurance, and late fee. If the credit card is declined or expired, and Borrower does not respond to Lender's calls, messages, emails, or letters, in one month past the Due Date Lender will automatically transfer Borrowers Account to Collections, and Borrower will be responsible for any court costs and attorney fees.
- Lender hereby denies any responsibility toward accidents or injuries that may occur from playing an instrument rented from the store. By signing a rental contract, Borrower acknowledges this statement in full.
- **Autopay:** Borrower can sign up for automatic payment for every month or every three months with a valid credit card. The Receipt of the transaction can be mailed back to Borrower's home only by his/her special request.
